## WELCOME/GOVERNANCE - PAUL LEGGETT

#### LT. GOVERNOR COMMENTS - TYLER CAIN

Tyler Cain expressed her gratitude to have participated on the Utah Philanthropy Day Selection Committee on behalf of the Lt. Governor's office. She shared a study that was released by WalletHub that says Utah is ranked #2 on the happiest and best wellbeing when being compared to all other states in the nation. The state of Utah also ranked #1 in volunteerism. For better or for worse we are helping our communities and there's a lot to be derived from that. As a state, trying to maximize our existence by helping our communities remains important and that is clear in the results of the study.

### POWER OF SERVICE AWARD - THE COMMISSION

The Commission presented the Power of Service Award to recipient Gayle Haas (Unable to Attend). Gayle Haas has been a volunteer at Court Appointed Special Advocates (CASA) of Washington County. Although she was unable to be present at the meeting, Paul Leggett read highlights of her volunteerism and the commission recognized her as the recipient.

### AMERICORPS PROGRAM REPORT - JACOB JOHNSON & CARRIE SCHONLOW

Three new programs started during this program year, one being Five County Association of Governments. This program will allow the organization to better serve rural Utah communities. These rural communities include Beaver, Iron, Garfield, Kane and Washington counties. Carrie Schonlaw (Deputy Director of Five County Association of Governments) shared the main objectives and mission of the organization. The program provides non-biased, person-centered support to address risk factors and improve the long-term health and wellness outcomes for low-income, older adults, individuals with disabilities and minorities.

## **DIRECTOR UPDATE-LADAWN STODDARD**

Strategic Plan Dashboard – LaDawn reviewed this year's Strategic Plan Dashboard for UServeUtah. Due to extenuating circumstances including the COVID-19 pandemic, the numbers are not reaching the current targets. There are plans in place and efforts have been made in adjusting outreach and training virtually such as AER and more trainings in the fourth quarter. Goals have been refocused and reimagined to be met in 2021.

Working with consultant through the national association for continuity planning. Staff have been completing playbooks for each position. Executive Committee will review current policies and bylaw to then present updated/revised pieces to the commission for review and approval in January 2021.

Vote carried unanimously.
